

District Skill Development, Employment and Entrepreneurship Guidance Centre, functioning under Skills, Employment, Entrepreneurship and Innovation Department, Government of Maharashtra and **District Skill Development, Employment and Entrepreneurship Guidance Centre Satara,** Maharashtra, which expression shall, unless repugnant to the context or meaning thereof, includes its successor in office and permitted assigns of the **FIRST PART.**

AND

Mahavidyala Kaushalya Vikas Kendra – Koyana Education Society ,Patan (TP234240)

Satara, which expression shall, unless repugnant to the context or meaning thereof, includes its successors, executors and administrators of the **SECOND PART.**

Hereinafter, **District Skill Development, Employment and Entrepreneurship Guidance Centre Satara,** and the **Mahavidyala Kaushalya Vikas Kendra – Koyana Education Society Patan (TP234240) Satara”, Balasaheb Desai College ,Patan (TC)** shall individually be referred to as the “Party” and shall collectively be referred to as the “Parties” wherever the context requires.

WHEREAS:

1. Definitions

“Applicable Law” shall mean all statutes, enactments and Acts of legislature, laws, ordinances, rules, bye-laws, regulations, notifications, guidelines, policies, directions, directives, treaties and orders of any authority which has or may have jurisdiction in respect of the subject matter herein (as may be amended from time to time).

“Training Program” means the training provided to candidates registered on Mahaswayam portal for the purpose of meeting the skill gap in the State of Maharashtra.

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL OBLIGATIONS HEREIN CONTAINED, TERMS AND CONDITIONS HEREINAFTER SET FORTH, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

2. Scope of Work

2.1. Establishing Mahavidyalaya Kaushalya Vikas Kendra (MKVK)

- a. The selected applicant in the shortlisting process shall establish a Training Centre in the identified location by MKVK-TP for establishing Mahavidyalaya Kaushalya Vikas Kendra.
- b. The Mahavidya Kaushalya Vikas Kendra – Training Centre (MKVK-TC) should be fully accredited on Skill India Portal (SIP) and empanelled on MSSDS Portal.
- c. MKVK-TP and DSDE&EGC shall jointly complete the process of on boarding of Training Centres on MSSDS Portal.
- d. Setting up virtual classrooms in the allocated locations.

2.2. Mobilization of Candidates:

- a. The MKVK-TP shall ensure that they undertake appropriate initiatives to mobilize candidates. Training Partners shall work out plan for candidates 'mobilization with support of MKVK-TP MSSDS/ DSDE&EGC shall support Training Program by its promotion in various ways at State/district level respectively.
- b. MKVK-TP shall conduct counseling of candidates prior and after allocation of target. MKVK-TP shall make every possible effort to mobilize needy candidates.
- c. Conduct registration of the mobilized candidates on SIP & MSSDS Portal.
- d. Conduct registration of the mobilized candidates on SIP & MSSDS Portal

2.3. Courses and Training:

- a. MKVK-TP shall plan the training sessions and ensure conduct of actual trainings as per agreed standards of training. MKVK-TP /TC shall be responsible for the quality of training as per applicable guidelines.
- b. The courses shall be as per the National Skills Qualifications Framework (NSQF), Qualification Packs (QPs).
- c. Capture daily attendance of candidates and Trainer on MSSDS Portal on attendance system recommended by the MSSDS.
- d. MKVK-TP will create training batches on MSSDS & SIP Portal.
- e. Post approval of Training batches on MSSDS Portal, initiate the skilling program as per allocated target for the locations under PMKUVA scheme

2.4. Assessment and Certification of candidates:

- a. For whole Training Program, assessment and certification of eligible candidates would be done by SSC/ MSBSVET, as agreed by both Parties.
- b. MSSDS shall pay the assessment fees to the Assessment Agency as per common cost norms.
- c. Assessment Agency shall submit the assessment reports to MSSDS as per scheme guidelines.

2.5. On Job Training /Placements of Candidates:

- a. The objective of the Training Program is to make the youth employable. Aligned with PMKVY 4.0, On Job Training (OJT) will be a component under PMKUVA Short Term Training (STT) as mandated by NCVET. The duration of OJT will depend on the job role selected. In case of the job roles for which the Job role duration is not defined guidelines issued from MSDE & NSDC from time to time needs to be followed.
- b. MKVK-TP shall verify and ensure that the training institutes maintain the OJT roaster and scanned copy of the OJT roaster must be submitted to MSSDS office. IT-based tracking of candidate's for on the job training and placement up to 1 year from the date of certification shall be done for all the candidates by SSC/TC as per PMKVY 4.0 guidelines.

2.6. Management Information System:

- a. MSSDS shall provide access to its technology platform for Data management and information management. MKVK-TP shall facilitate to maintain all records of Training Program on MSSDS's portal.
- b. MKVK-TP shall appoint/provide requisite manpower for smooth conduct of the Training Program. MKVK-TP shall deploy mechanism which will administer the Training Program and will report to MSSDS. MKVK-TP shall maintain all records, track candidates after completion of the Training Program and ensure to conduct all possible activities for handholding the trainees at least for a period of 1 year post placement. MKVK-TP shall designate single point of contact (SPoC) for the Training Program.

2.7. Other Covenants

- a. MKVK-TP and candidates in such Training Program shall in no way be termed and taken as employer-employees relationship. The candidates being trained are beneficiaries.
- b. MKVK-TP and their allied training partners shall comply with all rules and regulations of MSSDS/DSDE&EGC. Progress of the Training Program shall be reviewed on quarterly basis and dates will be decided mutually between the Parties.
- c. MSSDS/DSDE&EGC shall arrange for visits to the training centers for inspection/supervision in best possible manner and the suggestions made by MSSDS/DSDE&EGC shall be followed scrupulously by MKVK-TP and their allied training partners.

3. Term and Termination

3.1. Agreement will commence on the Effective Date and term therefor will be of 3 years. The Parties may mutually agree to renew the Agreement wholly or partially in writing. However, the MKVK-TP recognizes that time shall be essence of this Agreement and shall render its services accordingly. The training targets and batches for each successive year shall be done on the basis of satisfactory performance review at the end of each year.

Training of minimum one job-roles is to be imparted in each Mahavidyalaya Kaushalya Vikas Kendra.

3.2. Each Party may terminate this Agreement for breach of any terms and conditions of this Agreement by giving 30 (thirty) days 'prior written notice of its intent to terminate this Agreement to the other Party, except that each Party will be obligated to perform its outstanding obligations hereunder up to the date of termination.

Clause 4 (Confidentiality) and Clause 10 (d) (Indemnity) and this clause shall survive for 1 year after termination or expiry of this Agreement.

4. Roles And Responsibilities

4.1. Roles And Responsibilities of MSSDS

- a) MSSDS shall act as an implementing and monitoring agency and having full/partial control over the MKVK scheme component.
- b) MSSDS shall advertise, if needed, for mobilization of candidates for training under the scheme.
- c) MSSDS shall facilitate generation of Training Batch Number (TBN).
- d) MSSDS shall monitor and evaluate the performance of the TP.
- e) MSSDS shall monitor & review trainings.
- f) Extending support to MKVK-TP /TC in promotion of the program through district administration, media and social media.
- g) To review the progress of the Project.

4.2. Roles and Responsibilities of District Skill Development, Employment and Entrepreneurship Guidance Centre

- a) Extending support to TP in organizing Mobilization camps through District Skill Committee (DSC).
- b) TP shall inform regarding the schedule of training, venue & other details to DSC & Asst. Commissioner, District Skill Development Employment & Entrepreneurship Guidance Centre of respective District in which target is allotted.
- c) DSDE&EGC shall change the batch phase of Training Batch from 'yet to start' to 'ready to start' post verification of details.
- d) DSDE&EGC shall monitor and evaluate the performance of the MKVK-TP/TC.
- e) DSDE&EGC shall conduct surprise monitoring visits to the MKVK-TP/TC & review trainings.
- f) Extending support to MKVK-TP/TC in promotion of the program through district administration, media and social media.
- g) To review the progress of the Project and report to MSSDS.

4.3. Roles and Responsibilities of MKVK-TP and MKVK-TC

- a) MKVK-TP /TC shall agree to the norms of batch size, terms and conditions of payment as per scheme guidelines issued from time to time.
- b) MKVK-TP/TC shall issue admission notice, from time to time for the courses that are offered and may also circulate publicity materials such as pamphlets, brochures, etc. in order to create awareness about courses, facilities, etc.
- c) MKVK-TP/TC shall mobilize candidates who are eligible for getting trained in a specific job role for which approval has been granted by MSSDS.
- d) MKVK-TP/TC shall register and enroll candidate on Skill India Portal &

- Mahaswayam portal by providing all mandatory information.
- e) MKVK-TP/TC shall coordinate with the Assessor and Assessing body and ensure that assessment is carried out on the scheduled date for all candidates who appeared for training and are eligible for assessment.
 - f) MKVK-TP/TC shall comply with all the processes required to maintain information on the SIP & MSSDS portal and shall provide necessary IT infrastructure and manpower for the same.
 - g) MKVK-TP/TC shall maintain attendance of all candidates under training and trainers from start to end of training.
 - h) MKVK-TP/TC shall allow authorized officers of MSSDS / DSDE&EGC dealing to inspect the training infrastructure available in its premises for job roles for ongoing training.
 - i) MKVK-TP/TC shall abide by all the instructions issued by MSSDS / DSDE&EGC from time to time.
 - j) To provide documents of candidates to MSSDS as per requirement of scheme guidelines.
 - k) To associate with respective Sector Skill Council (SSC) and National Skill Development Corporation (NSDC).
 - l) To arrange tools & equipment for training.
 - m) To conduct training as per norms and scheme guidelines.
 - n) Mobilization and counseling of trainees.
 - o) Documentation and record keeping of the candidate details.
 - p) To conduct training of the selected candidates.
 - q) MKVK-TP/TC shall facilitate the process of distribution of the certificates to the candidates within the time limit as per scheme guidelines.
 - r) MKVK-TP/TC shall solely and exclusively responsible for all acts and omissions of its staff and any persons, associations, institutions engaged by it whether or not in the course of implementing the training program and for the health, safety and security of such persons or entities and their property.

5. Target & Project Cost

Locations of Mahavidyalaya Kaushal Vikas Kendra, No. of candidates, sectors, courses, duration of Training Program, assessment cost, cost per candidate, total project cost and target allocation, etc. will be as per the common cost norms or guidelines of Government of Maharashtra will be mentioned in respective work orders to be issued by District Skill Development, Employment and Entrepreneurship Guidance Centre to MKVK-TP from time to time.

6. Payment Terms

MSSDS shall make payment to MKVK-TP for conducting Training Program as per the payment terms mentioned in the common cost norms and relevant scheme guidelines as may be amend from time to time. The current payment terms will be as per the cost norms as per prevailing PMKUVA/ PMKVY4.0 guidelines

1	30% - On commencement of training
2	30% - On completion of 50 % training and proportionate to number of candidates achieving 70% AEBAS attendance of the 50 % training days.

4	Payment against the candidates passed in the reassessment. Any excess payment paid to be recovered in this milestone, if applicable.

- a) Non-adherence to PMKUVA and MKVK Scheme guideline will be liable for penal action as per Penalty Matrix
- b) MSSDS agrees to release payment upon completion of following activities and as per the scheme guidelines:
 - Satisfactory performance of each milestone by MKVK-TP
 - Timely creation of invoices on MSSDS portal on compliance and completion of milestone.
 - Milestone wise payment will be released as per compliance of scheme guidelines and availability of funds under the scheme.

7. Confidentiality

DSDE&EGC and MKVK-TP agree to hold in confidence all information/data designated as confidential, which is obtained/ disclosed from the disclosing Party and will not disclose the same to any third party without written consent of the other Party. The confidentiality obligations of both Parties contained in this clause shall remain binding on them during the term and for a period of one (1) year after completion or termination of this Agreement, regardless of the cause of such termination.

8. No Assignment

Neither of the Party to this Agreement will assign the Agreement to any third party without prior written consent of other Party.

9. Dispute Resolution

Any disputes arising out of or relating to this Agreement shall be referred to Sole Arbitrator appointed with the mutual consent of the Parties to the Agreement in accordance with the provisions of the Arbitration and Conciliation Act, 1996, as may be amended from time to time. The venue of arbitration shall be Concerned District, India.

10. Governing Law and Jurisdiction

This Agreement is to be construed, performed and enforced in accordance with the laws of India with exclusive jurisdiction of the Concerned District Courts, India.

11. Relationship

Nothing in this Agreement shall be construed to make either Party a partner; an agent or legal representative of the other for any purpose.

12. Intellectual Property Rights

Each Party shall retain exclusive interest in and ownership of its Intellectual Property developed before this Agreement or developed outside the scope of this Agreement. Both Parties agree to take prior permission of the other Party in writing before use of the Intellectual Property Rights of the other Party. Both Parties agree to immediately return all data including documents, information, reports and summaries whether written or oral, in electronic or hard copies, provided by one Party to the other Party after completion or termination of the Agreement.

13. Miscellaneous

- a) It is agreed between the Parties that this Agreement entered into between them is strictly on a principal-to-principal basis. Under no circumstance DSDE&EGC shall be deemed to have instructed, communicated or corresponded with any of the Second Party's employees concerning this Agreement. No relationship of employer and employee is created between DSDE&EGC and Second Party and / or any personnel engaged by Second Party. Second Party's employees deputed to perform / handle any activity under this SERVICE AGREEMENT shall not be eligible for any DSDE&EGC employee benefits.
- b) This Agreement shall be governed by the laws of India and subject to the exclusive jurisdiction of courts at Concerned District.
- c) Training target of up to 150 candidates for the first year will be allocated on the basis of implementation plan submitted by the selected MKVK-TP.
- d) Validity of the agreement will be 3 Years from the date of signing the agreement. However, training targets and batches for each successive year shall be done on the basis of satisfactory performance review at the end of each year. Training of minimum one job-role is to be imparted in each Mahavidyalaya Kaushalya Vikas Kendra.

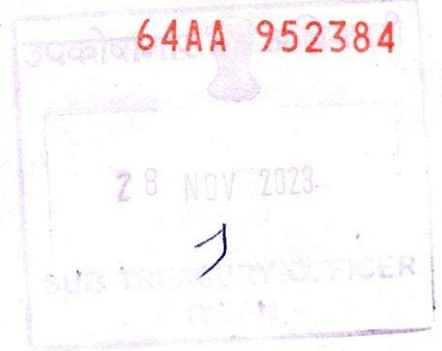

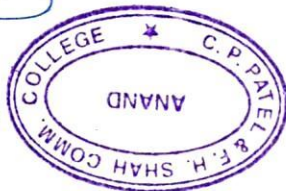
d. Both institutes will adhere to ethical practices, respect intellectual property rights, and maintain the highest standards of academic integrity throughout the collaboration.
