SCOPE OF THE MoU

This MoU aims to foster collaboration between academia and industry,

development to benefit students and faculty.

The key objectives include:

- Promoting collaboration for effective utilization of resources.
- Encouraging research, development, education, and training.
- Enhancing students' technical skills to meet industry demands.

AREAS OF COOPERATION

Skill Development Programs

The Company will conduct training programs on emerging technologies for students and faculty. Industry experts from the Company will deliver guest lectures.

Industrial Training & Visits

The Company will organize industrial visits and training sessions for students and faculty. A selection process will be conducted for students opting for industrial training.

Research and Development

Collaborative research activities may be initiated under separate agreements.

Faculty/Manpower Development Programs

The Company may assign industry-specific projects to students and faculty. Joint training programs for both industry and academia will be encouraged. The Institution will invite the Company to conferences, seminars, and technical meetings.

Internship & Placement Assistance

The Company may provide internship and placement opportunities to eligible students.

Financial Considerations

Any financial involvement will be decided upon mutual consent and documented before the commencement of activities.

Confidentiality

Both parties agree to maintain confidentiality regarding any proprietary or sensitive information exchanged under this MoU.

Amendments

Any modifications to this MoU must be mutually agreed upon and documented in writing.

Coordination & Dispute Resolution

Each party will designate a coordinator to monitor and review progress. Any disputes will be resolved amicably through mutual discussions.

Validity & Termination

This MoU will be **effective from 04/03/2025 to 03/03/2030**, with the possibility of extension upon review. Either party may terminate the agreement with a three-month written notice. Upon termination, both parties will fulfill their pending obligations but bear no further liabilities.
